Purpose:

This report recommends that Council consider additional changes and conduct further public consultation on proposed amendments to *Subordinate Local Law No. 2 (Animal Management) 2011*.

That Council resolve to proceed with the making of, and undertake further public consultation in relation to, Animal Management (Amendment) Subordinate Local Law (No.1) 2020 (formerly Animal Management (Amendment) Subordinate Local Law (No.1) 2019) in the form attached to this report. {recommendation-end}

Background:

Council at its General Meeting on the 19 November 2019 resolved to propose to make *Animal Management (Amendment) Subordinate Local Law (No.1) 2019.* The summary of changes proposed in the amending local law were as follows:

- a. add stock (cattle, horses, alpacas, asses, buffaloes, camels, deer, donkeys, goats, horses, llamas, mules, sheep, vicunas and pigs) as a category of animals that can be sold/re-homed without the need for public auction; and
- clarify that miniatures of breeds are also excluded in certain areas; changes to keeping of poultry; and the number of animals permitted to be kept on land between 10,001 and 20,000m² are better defined; and
- c. allow two dogs in multi-residential premises by permit; and
- d. require a top cover on enclosures for animals that can fly; and
- e. provide for animals used for commercial purposes such as camel or pony rides, etc in some public areas via a permit system; and
- f. identify additional dog off-leash areas proposal is to include the new dog exercise areas in Calliope and Bororen to be recognised as off-leash areas and the Boyne River foreshore as dog off-leash (excluding turtle nesting season).
- g. remove Barney Point Park, Prince Regent Esplanade and Friend Park Barney Point from prohibited areas for dogs to on-leash areas for dogs.

The proposal to make the amending local law was publicly advertised for community feedback for the period 23 November 2019 closing on the 20 December 2019. Seventeen people provided feedback (four submissions; thirteen survey responses).

At the close of public consultation, Council Officers carried out further internal consultation on the feedback received. Attachment 3 to this report summarises the issues considered in the post consultation meeting.

Officers are recommending that Council proceed with all changes proposed in *Animal Management (Amendment) Subordinate Local Law (No.1) 2019* subject to a minor amendment to the Boyne Island Foreshore proposal *(see point 3 below)* and include the following additional changes for public consultation.

- <u>Agnes Water Main Beach Off Leash</u>: That Council endorse conducting a community survey to determine a preferred option on changes to Dog Off-Leash areas for Agnes Water Main Beach limited to two options as shown in Attachment 3 to this report.
- 2. <u>Legislative References</u>: Update the legislative references in the subordinate local law from the *Apiaries Act 1982* to the *Biosecurity Act 2014* and from the *Sustainable Planning Act 2009* to *Planning Act 2016*.
- 3. <u>Boyne Island Foreshore</u>: That this area be designated off-leash for dogs all year round.
- 4. <u>Springs Beach and the foreshore south through to the northern boundary of the</u> <u>Deepwater National Park Agnes Water</u>: Be designated a 'Prohibited Area' for dogs.
- 5. <u>Chinamans Beach Agnes Water</u>: Be designated as an 'Off-Leash Area' for dogs.
- 6. <u>Caravan Parks</u>: That Council allow commercial caravan park operators to determine how many cats and dogs they will allow within the confines of their park in the knowledge that Council will still be able to manage enclosure and nuisance complaints if required, and set limits on the total number of animals to be kept onsite via its caravan park licensing provisions should it be needed.
- 7. <u>Millennium Esplanade</u>: correct an error in items 1 and 8 of schedule 6 to allow dogs to be walked through the Millennium Esplanade Park on-leash on the formed footpaths only.

Options, Risk and Opportunity Analysis:

Option 1 – Adopt the Recommendation

Should Council support the further changes as recommended, legal advice recommends that Council undertake further community consultation to ensure that individuals are given the opportunity to input into the changes that were not contemplated in *Animal Management (Amendment) Subordinate Local Law (No.1) 2019*.

The risks of not conducting further public consultation and proceeding with making an amending local law incorporating the changes not originally proposed in *Animal Management (Amendment) Subordinate Local Law (No.1) 2019* is that it may affect the validity of the amending subordinate local law.

<u>Option 2 – Adopt the Recommendation subject to changes to the Officer suggested</u> additions

If Councillors have concerns with the further changes to the amending subordinate local law proposed in this report, it may wish to change and/or delete the additional changes. The

risks associated with this option are similar to those outlined in Option 1. The resolution to give this option effect is:

"That Council resolve to proceed with the making of, and undertake further public consultation in relation to, Animal Management (Amendment) Subordinate Local Law (No.1) 2020 (formerly Animal Management (Amendment) Subordinate Local Law (No.1) 2019) in the form attached to this report, subject to the following changes:

- 1. Insert change

Option 3 – Adopt Animal Management (Amendment) Subordinate Local Law (No.1) 2019

Should Council be satisfied with the amendments originally proposed in *Animal Management* (*Amendment*) Subordinate Local Law (No.1) 2019, it could elect to adopt it without any further changes. The risk of this option is that Council will proceed with making amendments that do not include the full scope of considerations from the public submission process. It will however conclude the amendment process in advance of caretaker period.

"That Council:

- 1. Proceed with the making of, and make, Animal Management (Amendment) Subordinate Local Law (No.1) 2019 as advertised; and
- 2. Adopt, pursuant to Section 32 of the Local Government Act 2009, a consolidated version of Subordinate Local Law No. 2 (Animal Management) 2011 (copy to be attached to the minutes)."

Option 4 – Place the amending subordinate local law process on hold

Should Council elect not to proceed further with amending the subordinate local law at this time it may wish to suspend the review until after the 2020 local government elections. This option will see the process delayed which places the business at risk of having to recommence the process which will involve additional costs and resources. The resolution to give this option effect is:

"That Council hold over further considerations relating to the amendment of Subordinate Local Law No. 2 (Animal Management) 2011 until after the 2020 local government elections."

Communication and Consultation:

The proposal to make the amending local law was publicly advertised for community feedback for the period 23 November 2019 closing on the 20 December 2019. Council received four submissions (attachment 1) and 13 responses to its online survey (attachment 2).

On the close of public consultation internal stakeholders from the following areas of the business met to consider the feedback and develop recommendations to put forward for Council consideration:

- Governance
- Environment and Conservation
- Local Laws

- Biosecurity and Environmental Health
- Customer Experience

As a result of the submissions, the further internal considerations, and based on legal advice, officers are recommending that if Council supports the additional changes proposed, that further general and targeted public consultation be carried out.

Legal Strategy and Policy Implications:

Chapter 3 Part 1 of the *Local Government Act 2009* and Chapter 3 Part 1 of the *Local Government Regulation 2012* governs the process for making, amending and repealing local laws and subordinate local laws. Council also has a policy P-2018-10 Local Law Making Process which supports that legislative process.

Council has commenced the process of proposing to make an amending subordinate local law in accordance with legislative requirements. As a result of public consultation there has been a number of additional matters raised outside of the scope of the original amendments therefore, Council's legal advisers suggest that it would be appropriate to conduct a further round of public consultation to ensure that those affected by the additional proposals have the opportunity to make a submission.

Part 5 of Chapter 3 of the *Local Government Act 2009* prohibits Council from making a major policy decision during the local government election caretaker period. The definition of a *major policy decision* includes "*(f) to make, amend or repeal a local law*", this includes subordinate local laws. Therefore, if Council adopts the recommendation to conduct further public consultation, it will be unable to finalise the amendment process prior to the commencement of caretaker period.

Financial and Resource Implications:

The subordinate local law amendment will attract external legal costs for advice on the amendment process and associated drafting and advertising of the amending local law. The original estimate was \$3,750, however, should Council adopt the recommendation and conduct a further round of consultation, it is estimated that this may increase legal advice costs by approximately \$1,500 - \$2,000. This will be funded from Council's legal expenses budget.

In relation to resourcing, Council officer resources will be required from both the governance and community engagement areas to conduct further targeted public consultation and to present that feedback to Council. Depending on the outcome of the further public consultation and ultimately the position Council adopts, there may also be a need to fund new regulatory signage in those public areas where control designations change.

Summary of Public Submissions received 23 November 2019 to 20 December 2019 Animal Management (Amendment) Subordinate Local Law (No.1) 2019

SUBMISSION 1 – PRIVATE INDIVIDUAL

I believe it should remain as public auction as there is too much risk of stock which is not currently impounded suddenly becoming of interest to Council and Council having mates' freezers filled with stock via private sale. Open accountability must remain. Given the very low rates of current impoundment and Councils lack of interest or action in wandering stock and the cost to the community of such I feel any loss incurred by ratepayers of auctioning such stock is of little concern and is warranted in the benefit of accountability.

SUBMISSION 2 – PRIVATE INDIVIDUAL

I am writing to you regarding the by-laws involving the walking of dogs on Agnes Water Beach and the restriction effecting the many dog walkers along the beach.

We have been ratepayers since 1998 when our property at (address deleted for privacy reasons) was under Miriam Vale Shire. For the last 20 years we have walked our dogs on the beach at Agnes Water along with many others. We accessed the beach via Ocean Beach Drive. For most of the time the beach was an off lead area to the north. In recent years, the by-laws have been changed to restrict the off lead area. The nearest off lead area being north of the new Lifesaving Club, some 2 kilometres from our residence. Access requires the use of a vehicle. From talking with locals, there appears to be a resident with a vendetta against dogs. This person takes photos of dogs off lead and forwards them to the Shire complaining. The Shire is obligated to act. Our sympathy lies with the Ranger charged with the difficult task of managing an inappropriate and highly unpopular by-law.

With the change in demographics over the years, you will know that there are a lot more people using the beach to walk their dogs. Many being residents of Agnes Water Caravan Park for the winter months. From observations most walk their dogs early morning and are fastidious in removing dog droppings, utilising facilities provided by the Shire. If there is a complaint regarding dogs it is about people that let their dogs off lead south of the Ocean Beach Drive during the busy swimming hours of the day. I would suggest that the Shire canvas the multiple dog beach walkers to make dog regulations more flexible. In other Shires in Queensland and interstate there are regulations that appease most, give or take the fanatic odd ball. One beach we stayed at recently was Coolum Beach, a very busy tourist area and higher population than Agnes Water. That beach is a very good example of a beach managed to accommodate both holiday makers' and locals' requirements in regard to dog walking rules. It did not need a car drive to access the off lead area.

Should you require further input and coordination it is suggested that you arrange a meeting of all parties, including the irate resident, dog owners and Shire Officers.

SUBMISSION 3 – DISCOVERY COAST ENVIRONMENTAL GROUP

Please find the following suggestions for the Animal Management (Amendment) Subordinate Local Law (No.1) 2019. Item 'e' Identify dog off leash areas for Agnes Water beaches. The Discovery Coast Environmental Group suggests the following amendments to the current local law to include the following:

Springs Beach: be classed as a NO DOG beach, due to the number of Marine Turtles that nest along this beach and can be and are, disturbed in their nesting by dogs being present on this

beach. It is recommended that a sign stating such be placed on the road entrance at this point for people to observe before entering the carpark.

Chinamens Beach: (also known as Desal Beach) be classed as a designated Dog OFF LEASH beach, due to the number of Marine Turtles unsuccessfully laying along this beach due to the terrain and condition of this beach.

Agnes Water Main Beach: Dogs be allowed on the beach ON LEASH ONLY as this beach has a significant number of Marine Turtle nests but acknowledging that it is the most frequented beach by humans and pets alike, therefore correctly restraining dogs needs to be maintained. We acknowledge that the Local Law needs to be inclusive for all members of the public and feel the abovementioned recommendations accommodates the needs of all the community fairly.

SUBMISSION 4 – INTERNAL STAKEHOLDERS

Current proposed changes:

Proposed change	Comment
Lilley's Beach	 Support changes to designate as dog off-leash outside of turtle nesting season. Ensure that timeframes align with that of Chinamen's Beach. The inlet is known as South Trees Inlet, not Lilleys Inlet. Be aware that parts of Lilleys Beach is owned by Boyne Smelter – the supporting map should only indicate areas of Council-managed land. Lilley's Beach is also trafficked by 4WDs – has consideration been given to potential conflict between vehicles and off-leash dogs on the beach? Increased risk of a dog being hit?

Schedule 1 - Bees	 The <i>Apiaries Act 1982</i> has been repealed and bees are now regulated under the <i>Biosecurity Act 2014</i>. Perhaps there should be a Council application process for people to keep bees?

Schedule 6 – Prohibition of animals in public places	 Map of Agnes Water dog prohibited area includes an area of private property (owned by Agnes Water Caravan Park) – does Council have authority to do this? Why have two separate maps for Tannum Sands dog prohibited area and Millennium Park dog prohibited areas – can they be combined to a single area?

Schedule 6 – Prohibition of animals in public places – Addition of Springs Beach	 Current on-site signage at Springs Beach indicates that dogs are prohibited and references an old local law that is no longer current. Springs Beach is a known turtle nesting beach. Suggest including it as a dog prohibited area either year-round or within turtle breeding season (consistent with Chinamen's Beach).

Schedule 7 – Dog off-leash areas – Agnes Water Beach dog off-leash area	 There is feedback about the current off-leash area at Agnes Water Beach, including: The Discovery Coast Environment Group (DCEG) coordinate a turtle monitoring program and have indicated that the beaches north of the Surf Club are the most remote and support the highest value turtle nesting habitat, as well as other environmental values like migratory shorebirds. Feedback from residents indicates that the Surf Club beach access as not being an all-abilities access. The steepness and dynamic nature of the dunes in that area makes it not feasible to instate a flatter or surfaced access (as at Sandcastles access). The Surf Club is now being leased by the Steiner School and that carparking at the access may now be limited. Students from the Steiner School also regularly access the beach as part of their activities, resulting in increased interaction between children and off-leash dogs. There is no water available at the Surf Club beach for dog owners.









The options we intend to offer aim to provide the most pragmatic approach to regulation and enforcement allowing the community equitable access to enjoy a healthy pet friendly lifestyle.



Legal advice suggests an alternative interpretation, however, to provide more certainty for the purposes of enforcement it was agreed that caravan parks be excluded from Schedule 1 and 2 of the SLL and that caravan park operators continue to make commercial decisions in relation to the number of domestic pets that they allow in their facility. This will not affect Council's ability to continue to enforce enclosure requirements where required and address nuisance issues such as barking Legal advice also suggests that if Council becomes concerned about commercial caravan park operators making poor decisions about domestic pets that impact on other property owners, Council has the ability to set maximum numbers of domestic pets via its caravan park licensing process should it be required and manage the issue through this process. 


