Gladstone Regional Council invites local sporting clubs/organisations and fitness/wellness businesses to host a stall at the 2023 Sport and Active Living Expo being held on Sunday 11th June at the Philip Street Communities and Families Precinct. The expo provides the opportunity for sport and active living organisations to showcase their service to the Gladstone Region community and raise awareness of programs available across the community that promote positive wellbeing, healthy lifestyles, and social connections.

Not only will the event encourage the Gladstone Region community to become involved in physical activity and healthy lifestyles, it is also an opportunity to network with likeminded groups, boost participation levels and participate in free capacity building workshops hosted throughout the day. The Sport and Active Living Expo takes a holistic approach to improving the health and wellbeing of our community.

Who is eligible to submit an expression of interest?

Sporting Clubs/ Organisations and Fitness/ Wellness businesses are encouraged to submit an Expression of Interest to hold a stall at the Expo, promoting their Sporting Club/ Organisation or Fitness/ Wellness business. Please note the intent of the stall is to promote opportunities for participation and positive wellbeing, however no sales or monetary transactions are to take place at the event.

Please note that council will not accept expressions of interest from:

- Any business promoting multi-level marketing products;
- Cosmetic or beauty businesses/ retailers;
- Doctors or other allied health practitioners; and
- Massage therapists.

Gladstone Regional Council are required to comply with capacity restrictions. Therefore, if too many applications are received in any one category (for example, same sport or health/wellbeing field), Council will consider the best mix of Sporting Clubs/Organisations and Fitness/Wellness Businesses, will insofar as practicable, give priority to Sporting Clubs/Organisations and will assess all applications based on the order in which the applications are received.

What will be required of the successful applicants?

Successful Sporting Clubs/Organisations and Fitness/ Wellness businesses will be required to:

- Provide marquee (outdoor only), table and chairs for stall set up (indoor and outdoor options available)
- Sign and comply with GRC's Stallholder Deed;
- Provide a risk assessment for your stall (template will be provided)
- Provide a copy of your public liability insurance
- Ensure that two (2) delegates who hold blue cards, are available to attend the stall between 10am and 2pm;
- Wear closed in shoes and undertake any site inductions required by GRC;
- Provide flyers/information to the public regarding your sporting club/ organisation or fitness/wellness business.
- Stallholders can provide flyers or other promotional items to include in 100 x giveaway bags on the day. Copies/ items must be delivered to the Philip Street Communities and Families Precinct Ngallil Building by no later than 5pm, Friday 28 April 2023
